Please read the following extracts from the Firearms Act 1968 (section 21) and confirm that you are not:

- (1) A person who has been sentenced (to custody for life or) to preventive detention, or to imprisonment or to corrective training for a term of three years or more (or to youth custody (or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a term in a young offenders institution in Scotland, shall not at any time have a firearm or ammunition in his possession.
- (2) A person who has been sentenced to imprisonment for a term of three months or more but less than three years (or to youth custody (or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a term in a detention centre or in a young offenders institution In Scotland, shall not at any time before the expiration of the period of five years from the date of his release have a firearm or ammunition in his possession.

Explanatory note:

Section 21 prohibits the possession of a firearm and ammunition (under any circumstances), by any person who has been convicted of a crime and sentenced to a term of imprisonment (or its equivalent for young persons) of 3 months or more. The prohibition applies in all circumstances, including handling and firing at an approved shooting club or at a clay pigeon shoot where a certificate is not ordinarily required. It also applies to the possession or use of other categories of firearms and ammunition such as airguns or shot cartridges for which a certificate is not needed. A sentence of 3 months to 3 years attracts a 5-year prohibition; shorter sentences have no prohibition however sentences of longer than 3 years carry a lifetime ban.

Safety Notice

- 1. The insertion of breech flags into Firearms is compulsory at all times with the exception of:
 - · when cleared to fire on the range.
 - when being carried in a carry bag /case at the beginning and end of a session.
 - when not possible on an air weapon an approved method is to be used to demonstrate that the weapon is safe.
- 2. For Live Firearms the user must demonstrate that their weapons is safe to the range officer or other experienced person before leaving the range and entering the club room.
- 3. No loaded magazines are allowed in the club rooms
- 4. Hearing protection is compulsory whilst shooting and it is strongly recommended that eye protection be worn at all times whilst shooting.
